A006. SUBSCRIPTION TO AERONAUTICAL PUBLICATIONS - YEAR 2018

1. GENERAL

Legal and physical persons interested in subscribing to or renewing subscription to Latvian Aeronautical Information Publications for the year 2018 should complete and sign the attached Order Form, and send it by e-mail: **ais@lgs.lv** or by fax: **+371 67300660**.

All subscribers are requested to provide a value added tax (VAT) number.

Aeronautical Information Publications (AIP, AIP AMDT, SUPs and AICs) provided in the form of the electronic AIP (eAIP) are made available only on the AIS Latvia website https://ais.lgs.lv using direct electronic distribution.

The eAIP of the Republic of Latvia will be distributed to Aeronautical Information Services of ICAO Contracting States free of charge as stipulated in paragraph 2.3.5 of ICAO Annex 15. All other subscribers have to pay for their subscriptions in accordance with the current price list.

Note: If necessary, the appropriate Letters of Agreement between Latvian AIS and the next intended user may be used to manage the aeronautical information data chain.

Download of a new issue of eAIP will be available 42 days prior to coming into force of the new eAIP.

AIP Supplements and Circulars which are published between publications of two AIP Amendments are distributed by e-mail.

A monthly plain-language list of valid NOTAM, including indications of the latest AIP Amendments, AICs issued and a checklist of AIP Supplements is available on request, if submitted to the NOTAM Office with a 60- minute notice period. It will be sent by fax or e-mail.

REMARKS:

- 1. The price quoted for new eAIP (direct electronic distribution) subscriptions only applies during the first quarter of the year. For each subsequent quarter, a price reduction of 4 EUR per expired quarter applies.

*Access to eAIP download (direct electronic distribution)

Subscribers to the eAIP (direct electronic distribution) will receive access to the Latvian eAIP digital download. If you are a registered user of the AIS of Latvia website, please provide your account username when submitting the Order Form to request access to the digital download ("data distribution") page.

If you are not a registered user of the AIS of Latvia website, then please create an account on the AIS of Latvia website https://ais.lgs.lv (in case of difficulty during the registration process, please contact the AIS of Latvia via e-mail ais@lgs.lv).

When the access to the digital download page will be granted, after authorization, you will see a new item called "Data distribution" in the website menu on the left-hand side of the interface. Opening the "Data distribution" window will provide an option to download the actual and next issues of the eAIP for the subscribing year.

In order to download the eAIP archive from the "Data distribution" section, Java Runtime Environment should be installed on a device and the Java plug-in should be allowed in the web-browser (Internet Explorer is recommended). Please note that Mozilla Firefox and Google Chrome do not support Java plug-ins anymore. In case of difficulty, please refer to the "Java help" section of the Latvian AIS website.
