1. General

The download of the above-mentioned aeronautical information products is available only on the AIS Latvia website https://ais.lgs.lv, using direct electronic distribution, **free of charge**.

The download of a new issue of eAIP, a complete AIP amendment in PDF, AIP data set, terrain and obstacle data sets will be made available so as to reach recipients at least 28 days in advance of the effective date.

Detailed information on available terrain and obstacle data sets is provided in AIP GEN 3.1.6.

AIP SUP and AIC, which are published between the publications of two AIP AMDT, are distributed by e-mail.

Note: eAIP, AIP SUP, AIC and Aeronautical charts are also published and available on the AIS website (view mode).

2. Access to eAIP, complete AIP AMDT in PDF, AIP Data Set, Terrain and Obstacle Data Sets download (direct electronic distribution)

Subscribers to the eAIP, complete AIP AMDT in PDF, AIP data set, and terrain and obstacle data sets will receive access to the digital download (direct electronic distribution). If you are a registered user of the AIS of Latvia website, please provide your account username in the Order Form when submitting it to request access to the digital download.

If you are not a registered user of the AIS of Latvia website, please create an account on the AIS of Latvia website at https://ais.lgs.lv/user/register. If you encounter any difficulties during the registration process, please contact the AIS of Latvia via e-mail at ais@lgs.lv.

When access to the digital download page is granted after authorization, the new website menu section called "Data Distribution" will become available. Opening this section will provide an option to download the required product.

To download the eAIP, complete AIP AMDT in PDF, AIP data set, and terrain and obstacle data sets from the "Data distribution" section, select the appropriate file from the list of available downloads. CRC checksum is provided for every downloadable file, so you may check the integrity of the downloaded file manually using your tool or the tool provided by the AIS of Latvia (https://ais.lgs.lv/downloadCrcChecker).
