STANDARDISED PRESENTATION OF THE AIP SUBSECTIONS CONTAINING AIRSPACE LATERAL LIMITS

Ref: AIP ENR 2.1, ENR 5.1, ENR 5.2, ENR 5.5, EVAD AD 2.17, EVGA AD 2.17, EVLA AD 2.17, EVRA AD 2.17, EVRS AD 2.17, EVVA AD 2.17 and EVLU AD 3.16.

Taking into account the queries and feedback of the end users about the lateral limits of the airspaces published in a new edition of AIP of Latvia WEF 27 JAN 2022 where the airspace coordinates are provided in an AIP data set only, the AIS of Latvia issues this AIP supplement as temporary solution for those end users who are not able to handle digital data in order to support transition from AIP to digital data sets.

This supplement replaces AIRAC AIP SUP 007/2022 and introduces the changes to the following AIP subsections:
